



SCHEDULE OF 2019 FEES

Annual School Fee

AGBU Alexander Primary School is run on a private schooling system. All school fees are presented on account, normally by the second Friday of the term. Fees are payable within three weeks of distribution of invoices.

The **Annual School Fee** (Tuition *plus* Building Fund Contribution) is:

\$3,000 - Preparatory *As there is no government funding for under age students (under 5 on 31st July)*

\$2,200 - Kindergarten

\$2,600 - Years 1 - 6

PLEASE NOTE:

- The Board has made no changes to the Annual School Fee, with 0% increase since 2015.
- Sibling Discount for the third (3rd) child will continue to be 100%. The discount applies to the Annual School Fee only and excludes the Preparatory class.
- The Building Fund Contribution is Tax Deductible.
- The P & C Canteen Fee is per family (\$100 for one child, \$120 for two or more children).

Ancillary Fee

For accounting purposes, we have excluded “Art & Craft” and “Photocopying” charges from the Schedule of Book Fees. As these items are reported separately. They have been incorporated into an *Ancillary Fee*.

The *Ancillary Fee for 2019* is **\$210 for Prep** and **\$260 for K-6** (*GST free*) per student and is charged to your Term 1 Account.

Service Fee

The *Service Fee* covers the per capita expenses for the following:

Membership to The Association of Independent Schools of N.S.W.

Membership to the Association grants access to valuable information and facilities for development of educational and administrative policy. Students benefit mostly from the provision of professional development programs, facilitators and support personnel to equip teachers in the classroom. The Association also provides specialist consultants for a fee, to assist with individual student education programs particularly with special needs education. School grants are made available by the Commonwealth Government through the A.I.S. network in areas of Literacy & Numeracy and Community Languages.

Copyright Licences

Our school participates in copyright licence agreements to ensure the lawful reproduction of copyright materials. Copyright licences are payable on a per student basis for print material, music and specified electronic medium usage.

Student Accident Protection Plan

Our school has in place Student Accident Protection Plan. The entire student population is covered 24 hours per day, 365 days per year. The personal accident policy provides varying levels of assistance should one of our students have an accident. This ranges from financial support for medical issues to tuition support if they can't attend school. There is no need to complete individual application forms or provide personal details. Simply being enrolled at the school ensures your child is covered by this Plan. A Schedule of Benefits or more information on the Plan including claim forms are available on application to the School Office.

The *Service Fee for 2019* is **\$150** (*GST incl.*) per student and is charged to your Term 1 Account.

Parents are advised that entrance fees for academic competitions including the International Competitions & Assessments for Schools (ICAS) and National Assessment Plan Literacy And Numeracy (NAPLAN) have **not** been included in School Fees. Details about these and other activities will be forthcoming in the School Newsletters.
